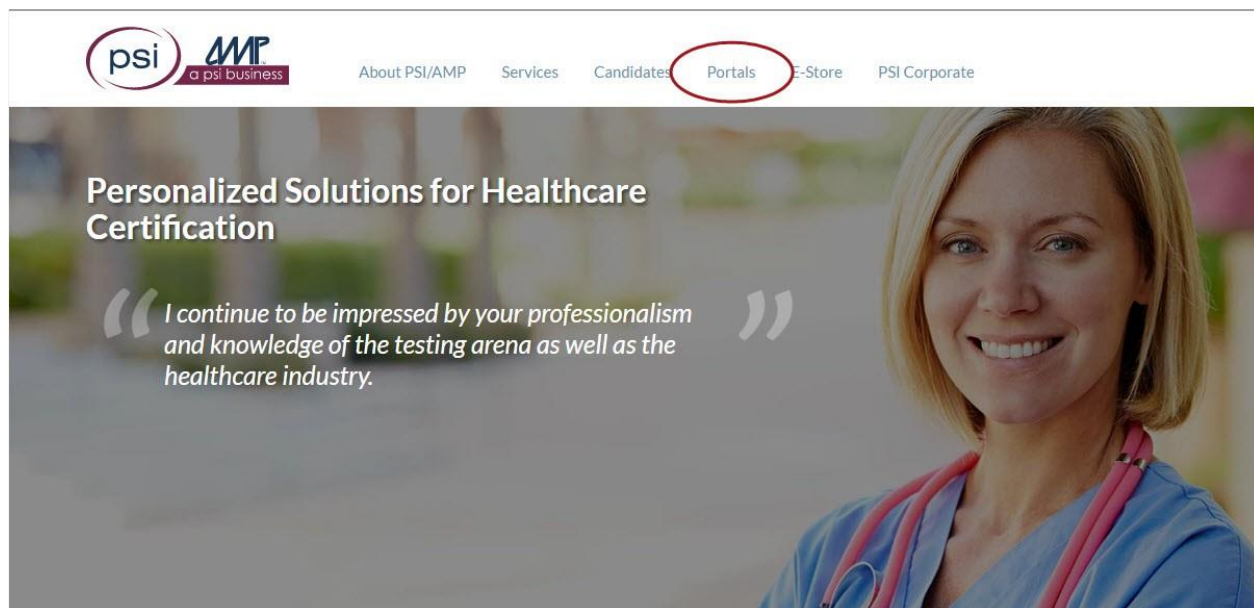
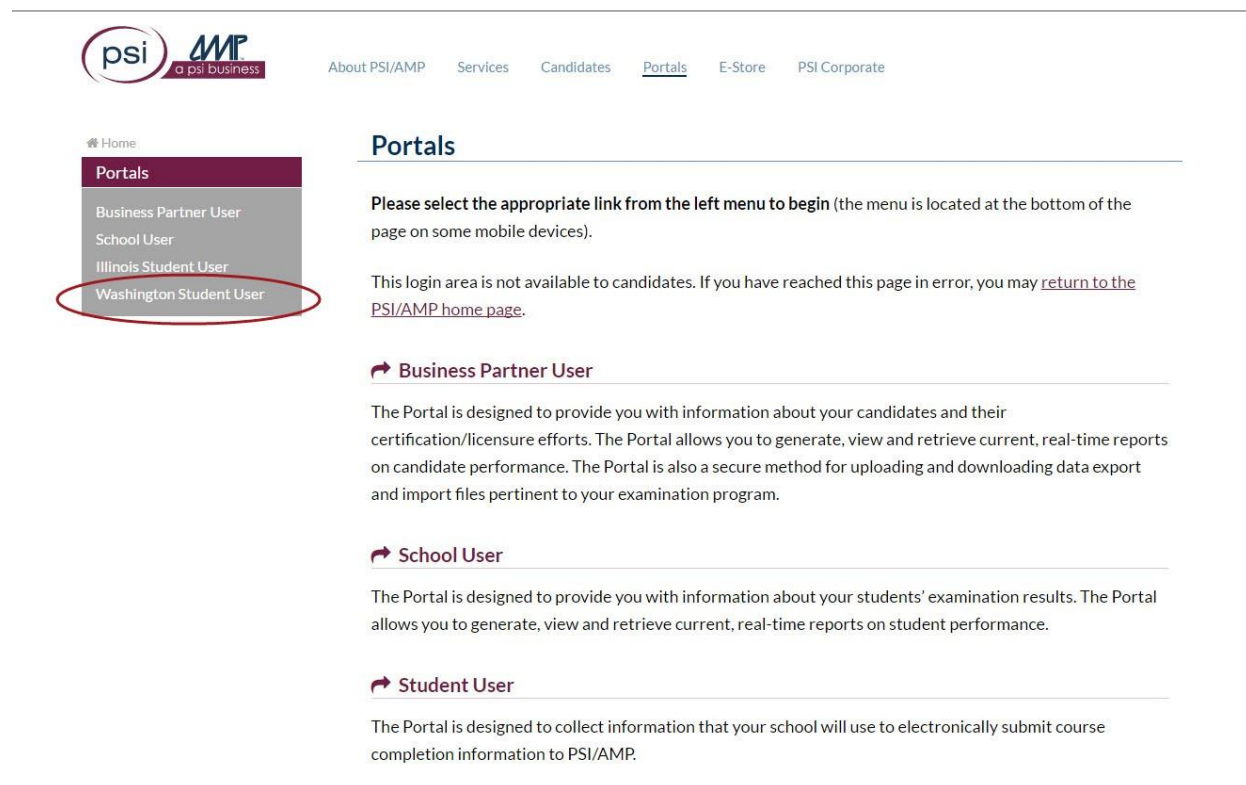


Washington Real Estate Student Reference Guide for the PSI/AMP Portal

To register as a Washington Real Estate pre-license student, go to the PSI/AMP Portal. Start at www.goAMP.com, and click on **Portals**.



On the next screen, select the **Washington Student User** option:

From the Student Login screen, click on **New Student Registration**. If you have previously registered as a Student User on the Portal, you can login by entering your Social Security Number (SSN) and password.

*(Note: your SSN will not be disclosed to educators or any other parties. The SSN is not required by the Washington Department of Licensing. If you provide a SSN or ITIN, it will be used in accordance with 42. U.S.C. 666(a)(13), RCW 74.20A.320 **and as your unique identifier to link your exam results to your license application**. If you do not have an SSN or ITIN, please leave that section blank.)*







You can access and change your student registration information until your school enters your course completion. Please note that your SSN will be used for your Username should you need to access your student registration information in the future.

You will receive an email message to acknowledge the receipt of your registration information. Please read and save this message. If you do not receive the message within an hour, please check any junk mail folders or spam filters.

VERY IMPORTANT: If any of your information changes before you become eligible to take your licensing examination, you may update your information by returning to the Washington Student User PSI/AMP Portal. Log in to your record by entering your SSN and password. (Note: If you forget your password, you can reset your password from the Student Login screen).

You will need to submit fingerprints for a background check when you apply for your initial license and every 6 years afterward. Fingerprint results must be cleared prior to issuing a license.
